<u>The Meeting</u>: The meeting was conducted as a Zoom hybrid. Selectboard Members Jon Collins and Rich Donaldson, Town Administrator Tyler Washburn, and Finance Director Mary McDonald were together in the Town Office. Selectboard Member Bronwen Tudor was on Zoom. There were 14 members of the public in attendance in person or on Zoom.

The minutes of the meeting of December 12<sup>th</sup>, 2023 and January 9<sup>th</sup>, 2024 were approved. They will be posted on the Town website.

<u>Most Important/Interesting Items</u>: In my judgment, the following items were the most important things covered during the meeting.

- Emergency Management Director Chris Wilcoxson updated the Selectboard regarding storm cleanup and ongoing discussions with MEMA and FEMA (Maine and Federal Emergency Management Agencies)
- Rich Donaldson would like to remind folks that a Demolition Permit is required in order to remove/demolish any existing structure greater than 100 square feet. The Demolition Permit is also important to ensure a structure is removed from the tax roles
- The Selectboard discussed the possibility and logistics of providing a dumpster or dumpsters in hard hit areas for storm cleanup
- Fire Chief Brian Whalen provided a synopsis of the Georgetown Fire Department (GFD) storm response
- The Selectboard approved the Recycling Contract with Lincoln County

#### **Public Comment:**

- Dave Polito told the Selectboard that the Solid Waste Committee (SWC) recommends approval of the Recycling Contract with Lincoln County
- Alison Freeman told the Selectboard that members of the SWC have seen the Recycling Contract with Lincoln County although they have not had a meeting since it was received so have not discussed it. In response to comments from Rich Donaldson, she said it is true that sometimes single stream recycling does end up being incinerated rather than being recycled, but that is unlikely to occur with recycling sent to Lincoln County because they use Maine Resource Recovery Association (MRRA) to broker their recycling. The reason Lincoln County sometimes asks the Transfer Station to make changes in what we accept is the ups and downs of the various commodities markets
- Bob Trabona commented that any dumpsters provided would need to be supervised. Poorly loaded dumpsters are not cost effective


