- Public Hearing: Liquor License for Four Cuckoo Birds LLC, dba The Osprey approved

- First Church Committee still has not received stamped drawings necessary to put work out to bid. Not clear as to why. Selectboard will send a letter to the engineers to clarify the request Lead and asbestos abatement and estimate for drainage remediation also still in process
- Amanda reported on ARP\$\$ -info regarding premium pay option and clarification from MMA
- Resignation from Calvin Stevens, ACO effective 4/30/2022. The job will be posted
- Appointment of Aria Eee to the Board of Appeals
- Town Meeting preparations initial discussion. The moderator from last year will be contacted about availability. Ordinance hearing, budget hearing, and candidates' night will be hybrid. Discussion about Town Meeting being inside or outside.
