## Report on the Selectboard Meeting of April 11, 2023

<u>The Meeting</u>: The meeting was conducted as a Zoom hybrid. Selectboard members Rich Donaldson and Jon Collins, and Finance Director, Mary McDonald, were together in the Town Office. Selectboard member, Bronwen Tudor and Town Administrator, Amanda Campbell were on Zoom. There were 7 members of the public in attendance on Zoom.

The minutes of the meeting of March 28, 2023, were approved as amended. They will be posted on the Town website.

<u>Most Important/Interesting Items</u>: In my judgment, the following items were the most important things covered during the meeting.

- The next Selectboard meeting on 4/25 will be entirely for discussion of the draft Town budget. This allows for one more meeting to make additional changes before the official presentation at the May 17th budget hearing
- Town Meeting logistics planning was discussed. Amanda will try to schedule the same Moderator as last year. There was some discussion of whether the meeting will be inside or outside, with a preference for inside. Setting up the tents outside presents logistical challenges due to volunteers needed to set them up
- The abandoned vessel, S/V Whisper, was discussed. The Town Attorney will be consulted
- Mary McDonald reported that there will be a GFD supervised burn of blueberry fields this weekend, weather permitting

Committee Liaison Updates:

- Bronwen Tudor reported that The Conservation Committee is continuing the search for a vendor to conduct a Level 3 Energy Audit with the grant from the Community Resilience Partnership.
- Jonathan Collins reported that the Shellfish Committee is considering a minor revision to the shellfish ordinance regarding waiving the requirement for conservation time for certain commercial harvesters
- Rich Donaldson reported that the Planning Board is considering a minor revision to the Solar Ordinance regarding maximum height of a Private Use Ground Mounted Solar Energy Systems
