This addition makes the DRAFT SOLAR ENERGY ORDINANCE consistent with the other ordinances that have an appeals process

Ole Jaeger, Chair of the Board of Appeals, brought the discrepancy to the attention of The Selectboard. They thanked Ole for his keen eye and attention to detail
