<u>The Meeting</u>: The meeting was conducted as a Zoom hybrid. Selectboard Members Selectboard Members Jon Collins and Aria Eee, Town Administrator Tyler Washburn, and Finance Director Mary McDonald were together in the Town Office. Selectboard Member Bronwen Tudor was on Zoom. There were at least 15 members of the public in attendance in person or on Zoom.

<u>Most Important/Interesting Items</u>: In my judgment, the following items were the most important things covered during the meeting.

- An off premise malt, spiritous, and vinous Liquor License for Georgetown General Store LLC was approved after a scheduled Public Meeting
- Georgetown Housing Initiative requested approval for use of some of Georgetown's MCOG (Midcoast Council of Governments) 16 technical assistance hours. The Selectboard approved use of 8 hours
- Town Administrator Tyler Washburn reported that the streetlight on Bay Point RD has been disconnected, but not yet removed. He asked for and received approval to continue research into the streetlight on Robinhood RD. According to CMP it is a Town owned light. There are options for relocation and improvement.
