<u>THE MEETING</u>: There were 2 members of the public present.

The minutes of the meeting of March 12, 2013 were approved.

<u>MOST IMPORTANT/INTERESTING ITEMS</u>: In my judgment, the following items were the most important things covered during the meeting.

Grey Havens Inn has submitted a liquor license application which requires a public hearing. The hearing will be scheduled concurrent with the next Selectmen meeting April 9th. Mary will post the notice.

The proposed contract for FY 2013-14 with R.C.Rogers for hauling Transfer Station MSW was received. Rates are approximately \$100/year.

Georgetown has not signed a 2013-14 contract with Coastal Humane Society. Kate MacKay is looking into other options (e.g. Lincoln County).

Jerry and Karin Gamache updated the Emergency Management Plan which was approved/signed by the Selectmen. The updated (minor revisions) plan will be posted on the Town web site.

The most interesting items were:

KELT is in the process of applying for accreditation to meet national quality standards. As part of that process, they are in the open for public comment phase. It was noted that KELT has about \$5 million worth of property in Georgetown.

One Veteran Exemption application and one Homestead Exemption application were received. It was noted that exemption applications must be submitted by April 1st to be considered this year.

A Tree Growth application for 10 year recertification was received from Orin Winn.
