

REPORT ON THE SELECTMEN'S MEETING OF June 24, 2014

THE MEETING: I was the only member of the public present for the whole meeting. Members of the Shellfish Conservation Committee also attended for a brief meeting.

The minutes of the meeting of June 10, 2014 were approved.

MOST IMPORTANT/INTERESTING ITEMS: In my judgment, the following items were the most important things covered during the meeting.

Chad Campbell, chairman of the Shellfish Conservation Committee, brought forward a recommendation from the committee to close Robinhood Cove to commercial digging. He explained that the committee believed the flats were depleted and needed time to recover. He had no specific data to support the committee position. Delores indicated that she did not agree with the strategy of closing only to commercial diggers. Bill indicated that he didn't agree with closing at all. At the end of discussion, the Board voted 2-1 to disapprove the proposed closure.

The Board agreed to meet June 30th to sign-off on final warrant, including the school warrant, for the fiscal year.

It was noted that there were 73 residents at the recent Town Meeting and there was no discussion whatever on any of the warrant issues. All were passed.

The Board discussed scheduling a "Summer Resident's meeting" for August 6th. The intent is to go over the Town Budget and items from the Annual Report plus respond to any questions.

The Board went through the list of appointments and committee members whose terms expire this summer. Mary will contact them individually about continuing another term.
