**THE MEETING:** The meeting was conducted as a Zoom hybrid. Selectboard members Rich Donaldson and Jon Collins, and administrator, Amanda Campbell, were together in the Town Office. Bronwen Tudor was on Zoom. There were 4 members of the public in attendance on Zoom.
